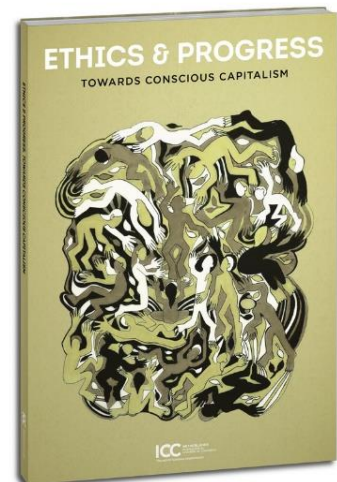

Robert Wade is a Professor of Global Political Economy at the London School of Economics and Political Science (LSE). He was awarded the Leontief Prize for Advancing the Frontiers of Economic Thought in 2008 and in 1992 the American Political Science Association's 'Best Book in Political Economy, 1989-91', for *Governing the Market: Economic Theory and the Role of Government in East Asia's Industrialization*. He worked earlier at the Institute of Development Studies, the World Bank, US Congress, Princeton University, MIT and Brown University.
